



AssetMinder® CBM Accelerator Bundle – Terms & Conditions

These Terms and Conditions ("T&Cs") govern the participation in the AssetMinder® **CBM Accelerator Bundle** ("Accelerator") provided by AssetMinder (Operations) Limited ("AssetMinder"). By purchasing the Accelerator, you ("the Customer") agree to abide by these T&Cs, in addition to the standard **AssetMinder (Operations) Limited Terms and Conditions**, which remain in full effect.

General Terms

1. The Accelerator is a **6-month trial** designed to help customers evaluate the benefits of Condition-Based Maintenance (CBM).
2. This trial includes the use of **four (4) AssetMinder® sensors**, which will be provided to the Customer for the trial period.
3. The Accelerator is available for purchase **online only**, with **full upfront payment required** before shipment.

Equipment Ownership & Return

4. All hardware provided as part of the Accelerator remains the exclusive property of **AssetMinder (Operations) Limited** throughout the trial period.
5. At the end of the **6-month trial**, the Customer is required to return all equipment to AssetMinder in **working condition**.
6. **An invoice for the full value of the equipment will be issued at the end of the trial**. Upon **successful return** of the equipment, a **credit note** will be issued to cancel the invoice.
7. If the equipment is not returned within **14 days** of the trial ending, AssetMinder reserves the right to **enforce payment of the issued invoice**.

Liability for Damage or Loss

8. The Customer is **fully responsible** for the safekeeping and proper use of the provided hardware during the trial period.
9. Any **damaged, lost, or unreturned equipment** shall be payable in full by the Customer at the invoiced amount.
10. AssetMinder reserves the right to **inspect all returned equipment** and determine if any damage has occurred.

Shipping & Returns

11. Shipping of the Accelerator hardware to the Customer is included in the purchase price.
12. **Return shipping costs are the responsibility of the Customer**.
13. The Customer must return all equipment using a **trackable and insured shipping method** to ensure safe delivery back to AssetMinder.

Payment Terms

14. The total cost of the **CBM Accelerator Bundle is £2,250**, payable **in full** at the time of purchase.
